The interdisciplinary model of care addresses all aspects of a survivor's wellbeing – from community and social connection, to legal, advocacy, mental health, and medical support.

Nancy J. Bothne is an associate professor in the clinical PsyD program of The Chicago School of Professional Psychology. Before entering the academic world, Nancy worked in international human rights advocacy. Understanding how human rights abuses create community trauma motivates Nancy's research and teaching. More recently, Nancy has examined how people reconstitute community life following periods of state sponsored human rights abuses and trauma. Nancy earned her PhD in community psychology from DePaul University.

Amid challenges, AAUW remains committed to advocating for women and communities of color's equal access to affordable, quality higher education.

AAUW celebrated Black Equal Pay Day on July 27th. This recognizing the day that, after seven months of extra work, Black women have finally caught up to the average earnings of a white man in 2022.

ARCH AWARD INSTRUCTIONS

AAUW-IL has set aside funds to assist members attending the Central State Regional Conference on Thursday, October 19, 2023, at Noon until Saturday, October 21, 2023, at 1P. The conference is the result of a co-operative of 11 states and the product of extensive planning. The scholarship may be used for registration, hotel rooms and transportation. Registration for the event is located on the AAUW-IL website or the AAUW-MO website and has been emailed through several state and branch communications.

The ARCH Award (AAUW REGIONAL CONFERENCE HELP) is a separate application since the scholarship is for our Illinois Members in particular. The award is restricted to one per branch and is open to the President, Administrator or Designate of the President. The Maximum allowed is \$400 and will be reimbursed retroactively.

Requests will be accepted until October 10, 2023, so that AAUW-IL can plan for the total monies needed. If you qualify and plan to go, please send an email to carolheisler@gmail.com. Your email must contain this information: In the subject line, put ARCH AWARD Request. In the body of the email list the following items:

Name, Mailing Address, Cell Phone, Current Position in your branch. If you are going as a Designate of your Branch President, please confirm this with her. Please explain the amount you are requesting. For example: hotel room @ \$\$, transportation expense (if you are driving the number of miles x .655 per mile) \$\$, Registration @ \$\$. The maximum amount reimbursed is \$400.
