AAUW-IL Legislative Update

Our lobbyist has been reading through thousands of bills to send hundreds of bills to Tracey and me to consider for AAUW's involvement in 2024. As in the last several years, there are many bills to reduce access to abortion health care. Many Illinois legislators are supportive of women's health care; however, we will follow these bills and oppose them in committee. There are also bills that reinforce women's health care and those who provide the services.

Last year, we worked very hard and appreciate all your help to end the Invest in Kids Scholarship Program. Our legislators are divided on this issue, and it was difficult to defeat. This session there are several bills to begin this program again. As you remember, this takes public money to be used in private schools. We must defeat these bills to revive Invest in Kids.

There are several bills that require Equal Pay Transparency and/or require corporations to share the makeup of their boards by race, gender, ethnicity and veteran status. There are several bills that eliminate the death penalty in Illinois. Tracey and I have determined that these bills are not part of the AAUW focus. Because this is an election year, complicated legislation will probably not pass. This includes our Paid Family and Medical Leave Insurance Program. Conversations have been going on to determine what we can give up and still have a good bill that we can pass, in the next session. We need you to ask your legislators to co-sponsor the bill.

Tentatively, we are looking at Wednesday May 8, 2024, for a lobby day. Most likely partnering with Planned Parenthood. We will let you know when we have more definitive plans. Thanks for all you do!
